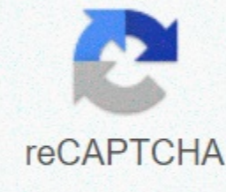

## Why does the grand inquisitor look like the son

The Great Inquisitor Ezra Bridger[src] The Great Inquisitor was a name adopted by the Pau'an Jedi Knight, who turned to the dark side of the Force and became the leader of the Inquisition, a group of Jedi hunters who served the Galactic Empire. The Grand Inquisitor was once a Jedi temple guard and participated in the events surrounding the bombing of the Jedi Temple during the Clone Wars, arresting innocent and later acquitted Padawan Ahsoka Tano, as well as the real culprit, Barriss Offee. After his fall to the dark side, the Grand Inquisitor was responsible for hunting and destroying the Jedi during the Great Purge of the Jedi. He personally served The Sith Lord Darth Vader, from whom he received his orders, and knew intimately the records of the Jedi Temple. The Grand Inquisitor was actively interested in destroying the rebel crew of the Starship Ghost, in particular Jedi Kanan Jarrus and his padawan Ezra Bridger. He met these two Jedi on numerous occasions, including a duel on Stygeon Prime and a duel at the Fort Anaxes asteroid base. After the Great Inquisitor and the Lothian government from which the insurgents operated were consistently unable to eliminate the rebels, the great Moff Wilhuff Tarkin came to Lothal to hunt the rebels. Together, they captured Jarrus, hoping to use him to learn more about the larger insurgent movement operating in the galaxy. They brought Jarrus to Mustafar, where the insurgents launched a rescue mission in orbit. During the operation, the Great Inquisitor engaged Jarrus and Bridger in a lightsaber fight, and Jarrus eventually defeated him. Rather than face darth vader's infamous wrath for his repeated failures, the great inquisitor decided to fall to his death. After Pau'an's death over Mustafar, former Jedi Grand Master Yoda used the vision of the Great Inquisitor as his former Guardian of the Jedi Temple to appear before Jarrus at the Jedi Temple on Lothal. In the vision, this Sentinel warned Jarrus that Bridger might fall on the dark side, and they both engaged in a lightsaber fight. After Jarrus refused to fight on, the Sentinel knighted Jarrus and told him he was a Jedi knight like the great Inquisitor. But despite the Inquisitor's physical death, Vader still had a use for him. The Dark Lord of the Sith was able to prevent the Inquisitor's spirit from surrendering, instead tying him to a Jedi base on Tempes. Here remained his spirit and killed all who sought Jedi knowledge. After losing his lightsaber at 3:00 a.m., Vader's own son Luke Skywalker met the spirit of the Inquisitor on Tempes. The two of them engaged in a duel in which young Skywalker came out. As punishment for allowing the boy to escape, Vader rejected Pau'an's pleas to be released from prison and had him guard the base for what the Inquisitor believed would be an eternity. Biography Early Life and Chivalry You are what I once was: a knight of the Jedi Order. The Pau'an male, who will one day become a great inquisitor, came from the planet Utapau.[1] where he was born more than fifteen years before the invasion of Naboo. [2] At some point, he became a member of the Jedi Order and became a Jedi knight. As a Jedi, he served in the Jedi Temple Guard,[7] a group of Jedi assigned to defend the Jedi Temple on Coruscant. [11] During his time as a Jedi knight, he had grown a jedi-unsuitable hatred for the chief librarian, Jocasta Nu, because when he went to the Jedi archives to read the data files, he was closely monitored because she considered him unfit for education. [12] The trial of Ahsoka Tano The future Grand Inquisitor was one of the Jedi temple guards who brought Barriss Offee before Supreme Chancellor Palpatine. During the clone wars, during a period of protest against the High Council of the Jedi for their continued leadership in the war between the Galactic Republic and the Confederation of Independent Systems, the bombing of the Jedi Temple shook the Jedi Order. [13] Although the real culprit was Padawan Barriss Offee, who believed that the Jedi Order had lost its way and that they were the real villains in the war against the Confederacy, she blamed it on her friend and colleague Padawan Ahsoka Tano for the crime. Tano fled to the underworld of Coruscant, far from the Great Army of republic forces that pursued her, but was eventually captured and brought to the Jedi Temple. She was brought before the Jedi Council, which stripped her of her Padawan status and expelled her from the Jedi Order. [11] The future Grand Inquisitor was one of the guardians who led Tano from the Jedi Temple.[14] and was eventually brought to justice before The Supreme Chancellor Palpatine. During the trial, Tan's master, Jedi Knight Anakin Skywalker, discovered Offee's duplication and had her arrested. [11] The future Grand Inquisitor was one of the guards who accompanied Offee to the trial,[15] where she pleaded guilty before the Chancellor and was subsequently removed by the guards. Tano was acquitted, but refused to rejoin the Jedi Order[11] and decided to seek a new path. [16] Fall on the dark side Do you know that the Emperor personally chose me, Vader? He raised me, gave me this position. He believes in my abilities. The Great Inquisitor, Darth Vader[src] Pau'an Jedi, became a Jedi hunter and servant of the Sith. The events with Offe and Tan left the future great inquisitor dissatisfied, and he lost faith in the Jedi Order. This left him prone to the pull of the dark side. Strength and eventually fell to the dark side. [15] At the end of the war, the Supreme Chancellor - secretly Darth Sidious, Dark Lord of the Sith - transformed the Republic into the Galactic Empire and declared himself emperor of the galaxy. During this time, Sidious recruited him to become the great inquisitor of the Inquisition. [15] The age of the Empire serving Lord Vader the Inquisitor entered the service of the Reich and the Sith, even though he was not a Sith himself. When the Inquisitor entered the archives of the Jedi Temple, he was confronted by Sith Lord Darth Vader, who was once Anakin Skywalker before his own fall to the dark side. He and Vader argued until Vader damaged his lightsaber. The fight was then stopped by the Emperor, who explained to Lord Vader who the Inquisitor and inquisitor were. They then went to the inquisition headquarters in the Works to meet the other Inquisitor. [9] Vader then commissioned the Inquisitor to hunt down and eliminate all Jedi who survived Order 66.[1] an order given to clone soldiers of the Great Army of the Republic to destroy the Jedi Order. Luminara Unduli's hologram, taken as she looked up to the Inquisitor in the moments before her death One such Jedi that the Inquisitor led to their deaths, was Jedi Master Luminara Unduli. After the execution of Order 66, Unduli was captured and held in Spire.[18] a former separatist[19] imperial prison on Stygeon Prime. [18] At the end of it, Unduli was in the presence of the Inquisitor, who was standing in the doorway of her cell when she entered the execution chamber and died. The Inquisitor kept her remains in a prison cell and used them to steer other Jedi to their deaths when they heard rumors that Unduli was still alive. [15] As part of this ruse, the Empire retained a holographic recording of Unduli and her executions. [18] When he became the Rank of Grand Inquisitor, he led other members of the Inquisition. Among these inquisitors were dark warriors such as the Second Sister, the Fifth Brother,[20] the Sixth Brother,[21] the Seventh Sister,[20] the Eighth Brother[22] and the Ninth Sister. Like the Great Inquisitor, these Inquisitors had their roots in the Jedi Order. [12] As a great inquisitor, the dark adept hunted and fought the former Jedi padawan naq honey. His lightsaber was damaged in a duel, and Med escaped.[23] At another point, the Grand Inquisitor took power-sensitive children from an orphanage on Gaaten. Even though he wanted to hunt down the alleged Jedi himself, he needed it elsewhere, and instead assigned the task to the Sixth Brother, who then went to Raada to set a trap for sensitive forces. In the following battle, however, he was killed, and the Jedi, as well as the farmers who rebelled against the recent occupation, fled. Meanwhile, the Grand Inquisitor was alerted to the situation and traveled to the moon with a fleet of Star destroyers to provide reinforcements, but by the time they arrived, the insurgents were gone. The Grand Inquisitor personally examined the damage caused by the battle and discovered the corpse of the Sixth Brother. Although he was upset by the incompetence and recklessness of his subordinate, the Great Inquisitor was impressed by what the Jedi had done. Then he returned to his ship and ordered his agents to set a course back to base and inform Darth Vader that they had found evidence of another survivor - in fact, it was Ahsoka Tano, Anakin Skywalker's former padawan. [21] Jedi on Kashyyyk At 14 BBY, the Great Inquisitor heard about the Jedi who caused problems for the Kashyyyk Empire. This Jedi was Cal Kestis, who helped some guerrillas attack the Imperial Refinery. The ninth sister told the great inquisition that Kestis would not have the courage to return to Kashyyyk, especially after the resistance had been eliminated by the Sororm. The ninth sister was later proved bad and defeated by Kestis when he returned to Kashyyyk. [26] The Children of the Force The Emperor foresaw that a new threat would arise against him: the children of the Force. It must not become Jedi. Yes, Lord Vader. Darth Vader and the Great Inquisitor[src] In the years before the Battle of Yavin, the Great Inquisitor was contacted by Darth Vader, who told the Jedi hunter that the Emperor foresaw a new threat that would arise to challenge his rule: the children of a force that could not be allowed to become Jedi. Vader ordered the Inquisition to hunt these individuals down and either to serve the Empire or destroy them, along with jedi survivors who could train them. With orders from the Emperor, the Inquisitor told Vader that it had happened. [27] The Grand Inquisitor was ordered by Darth Vader to hunt the children of the Force. One of the methods used by the Inquisitor to find people sensitive to force was to look cadets from the Academy of Young Imperials at Lothal who met a set of criteria that indicated their ability to use the Force.[28] an operation known as Project Harvester. One of the well-known targets of the Harvester project was Dhara Leonis, a promising cadet and daughter of imperial agricultural scientists. The imperial authorities tried to cover up her abduction by claiming she had escaped from the Academy. But her mother Tephra and younger brother Zare Leonis suspected the Empire was lying. To find out his sister's fate, Zare enrolled at the Academy the following year. [30] A little later, fourteen years after the rise of the Reich, a group of rebels operating on Lothal came to the attention of Agent Kallus of the Imperial Security Office. The insurgents rescued a group of Wookiees who had been enslaved at a spice mine in Kessel, a mission in which rebel leader Kanan Jarrus used a lightsaber to reveal himself as a Jedi survivor. After the rebels fled, Kallus contacted the Inquisitor and informed him of what had happened on Kessel. The Inquisitor was pleased that Kallus informed him of the rebel cell and the Jedi in its ranks. [27] Stygeon Prime Trap Yes, I'm afraid Master Luminara died with the Republic, but her bones continue to serve the Empire. He lured the last Jedi to the end. The Great Inquisitor Kanan Jarrus and Ezra Bridger[src] The Grand Inquisitor set a trap for Jarrus and his padawan Ezra Bridger in the Tower. The Empire was able to project an image suggesting that he was alive, and this information was then reported by Gall Trayvis, a former member of the Imperial Senate, who claimed to have gone into exile after speaking out against the Empire[18] - in fact, Trayvis was a loyal agent of the Empire who used his position to trap rebel groups into the traps of the galaxy around the galaxy. [31] The rebels did not want to miss the opportunity to save the surviving Jedi and made a mission to the Tower, where they intended to save the Jedi Master. After failing to stop the rebels on Stygeon Prime, the Inquisitor was contacted by Commander Cumberlayn Areske, a senior officer at the Imperial Academy at Lothal, who informed him of two students who potentially met his criteria for sensitivity to force. He learned that these cadets were Dev Morgan - who was unknown to the Academy, Bridger in disguise, who infiltrated the Academy to find out the location of a huge cyber crystal of great power - and Jai Kell. After the Inquisitor learned this information, he told Aresk through a hologram that he would arrive at the Imperial Academy the next day. During the escape, Leonis decided to stay to find out what happened to his sister, pretending to try to stop Bridger and Kell from escaping. The Inquisitor spoke to Leonis and told the cadet to tell him everything he knew about Bridger and Kell. During a private conversation with Leonis, the Inquisitor led the young cadet into the interrogation room. Once inside, the Inquisitor asked Leonis everything he knew about Morgan while he tried to explore the cadet's thoughts. While Leonis hid his collaboration with Morgan, he pretended to support the Inquisitor's assessment that there was something wrong with Morgan. The Great Inquisitor probing Zare Leonis[src] After the Lothian rebels attacked the Celebrations of Empire Day, the Great Inquisitor returned to Lothal to deal with another unfinished business: Dhara Leonis' younger brother Zare Leonis. While Zare was a promising cadet at the Academy of Young Imperials who earned the glowing praise of his instructors, the Inquisitor suspected Leonis was associated with Ezra Bridger and other Lothian rebels. A great opportunity for his action against Zare came when a young cadet took action against a ruthless cadet named Nazhros Oleg who tried to protect his smuggling uncles from imperial justice. Throughout the meeting, the Inquisitor tried to explore Leonis' thoughts. [34] The Grand Inquisitor suspected that Leonis had ties to the rebels, thanks to his association with Ezra Bridger. Leonis pretended to be a model cadet and expressed gratitude for the opportunity to serve the Empire. The Inquisitor senses Leonis' real motivations for joining the Imperial Academy and instructs Leonis by asking who might doubt the devotion of such a promising young cadet. Intimidated by the Inquisitor, Zare turned away from pau'an's gaze and called on the Inquisitor to ask the cadet to make eye contact with him. [34] Later, the Inquisitor visited the Arkanis Academy and landed in Area Null, a remote tower of the academy that hosted several top-secret imperial projects, including the Harvester project and the Unity Project, which was a program to educate former dissident youth. After dinner with Commander Brendl Hux and the cadets in the academy banquet hall, the Inquisitor summoned Cadet Leonis for a private meeting on the commander's balcony. There, the Inquisitor asked Leonis why he had tried to enter null, even though it was forbidden for cadets. Leonis said he thought the cadet was in trouble, but the Inquisitor quickly realized he was lying. [35] He then gave Leonis a second chance to answer his question. Jarrus escaped, but Sloane remained on Lahn when she was confronted by the Inquisitor, who wanted to know everything she knew about Jarrus. Reports of insurgent activity reached the highest levels of imperial rule, and concerns began to emerge because Lothal's industry was vital to the Empire's expansion into the Outer Rim. Immediately upon arrival, Tarkin foiled Minister Maketh Tuu and Agent Kallus for their failure to stop the uprising. He also dismissed rumors that the rebels were led by a Jedi, claiming that all the Jedi had died in the purge and that he knew because he had witnessed it. Later that day, Tarkin summoned Cumberlayne Aresk commander and taskmaster Myles Grint, who had been pursuing the rebels for some time and who had failed at every turn. After a brief conversation during which he revealed that other insurgent cells were active in the Reich and rumors that the Jedi are waging a rebellion could inspire hope and encourage unity, Tarkin informed the assembled

The Great Inquisitor Ezra Bridger[src] The Great Inquisitor was a name adopted by the Pau'an Jedi Knight, who turned to the dark side of the Force and became the leader of the Inquisition, a group of Jedi hunters who served the Galactic Empire. The Grand Inquisitor was once a Jedi temple guard and participated in the events surrounding the bombing of the Jedi Temple during the Clone Wars, arresting innocent and later acquitted Padawan Ahsoka Tano, as well as the real culprit, Barriss Offee. After his fall to the dark side, the Grand Inquisitor was responsible for hunting and destroying the Jedi during the Great Purge of the Jedi. He personally served The Sith Lord Darth Vader, from whom he received his orders, and knew intimately the records of the Jedi Temple. The Grand Inquisitor was actively interested in destroying the rebel crew of the Starship Ghost, in particular Jedi Kanan Jarrus and his padawan Ezra Bridger. He met these two Jedi on numerous occasions, including a duel on Stygeon Prime and a duel at the Fort Anaxes asteroid base. After the Great Inquisitor and the Lothian government from which the insurgents operated were consistently unable to eliminate the rebels, the great Moff Wilhuff Tarkin came to Lothal to hunt the rebels. Together, they captured Jarrus, hoping to use him to learn more about the larger insurgent movement operating in the galaxy. They brought Jarrus to Mustafar, where the insurgents launched a rescue mission in orbit. During the operation, the Great Inquisitor engaged Jarrus and Bridger in a lightsaber fight, and Jarrus eventually defeated him. Rather than face darth vader's infamous wrath for his repeated failures, the great inquisitor decided to fall to his death. After Pau'an's death over Mustafar, former Jedi Grand Master Yoda used the vision of the Great Inquisitor as his former Guardian of the Jedi Temple to appear before Jarrus at the Jedi Temple on Lothal. In the vision, this Sentinel warned Jarrus that Bridger might fall on the dark side, and they both engaged in a lightsaber fight. After Jarrus refused to fight on, the Sentinel knighted Jarrus and told him he was a Jedi knight like the great Inquisitor. But despite the Inquisitor's physical death, Vader still had a use for him. The Dark Lord of the Sith was able to prevent the Inquisitor's spirit from surrendering, instead tying him to a Jedi base on Tempes. Here remained his spirit and killed all who sought Jedi knowledge. After losing his lightsaber at 3:00 a.m., Vader's own son Luke Skywalker met the spirit of the Inquisitor on Tempes. The two of them engaged in a duel in which young Skywalker came out. As punishment for allowing the boy to escape, Vader rejected Pau'an's pleas to be released from prison and had him guard the base for what the Inquisitor believed would be an eternity. Biography Early Life and Chivalry You are what I once was: a knight of the Jedi Order. The Pau'an male, who will one day become a great inquisitor, came from the planet Utapau.[1] where he was born more than fifteen years before the invasion of Naboo. [2] At some point, he became a member of the Jedi Order and became a Jedi knight. As a Jedi, he served in the Jedi Temple Guard,[7] a group of Jedi assigned to defend the Jedi Temple on Coruscant. [11] During his time as a Jedi knight, he had grown a jedi-unsuitable hatred for the chief librarian, Jocasta Nu, because when he went to the Jedi archives to read the data files, he was closely monitored because she considered him unfit for education. [12] The trial of Ahsoka Tano The future Grand Inquisitor was one of the Jedi temple guards who brought Barriss Offee before Supreme Chancellor Palpatine. During the clone wars, during a period of protest against the High Council of the Jedi for their continued leadership in the war between the Galactic Republic and the Confederation of Independent Systems, the bombing of the Jedi Temple shook the Jedi Order. [13] Although the real culprit was Padawan Barriss Offee, who believed that the Jedi Order had lost its way and that they were the real villains in the war against the Confederacy, she blamed it on her friend and colleague Padawan Ahsoka Tano for the crime. Tano fled to the underworld of Coruscant, far from the Great Army of republic forces that pursued her, but was eventually captured and brought to the Jedi Temple. She was brought before the Jedi Council, which stripped her of her Padawan status and expelled her from the Jedi Order. [11] The future Grand Inquisitor was one of the guardians who led Tano from the Jedi Temple.[14] and was eventually brought to justice before The Supreme Chancellor Palpatine. During the trial, Tan's master, Jedi Knight Anakin Skywalker, discovered Offee's duplication and had her arrested. [11] The future Grand Inquisitor was one of the guards who accompanied Offee to the trial,[15] where she pleaded guilty before the Chancellor and was subsequently removed by the guards. Tano was acquitted, but refused to rejoin the Jedi Order[11] and decided to seek a new path. [16] Fall on the dark side Do you know that the Emperor personally chose me, Vader? He raised me, gave me this position. He believes in my abilities. The Great Inquisitor, Darth Vader[src] Pau'an Jedi, became a Jedi hunter and servant of the Sith. The events with Offe and Tan left the future great inquisitor dissatisfied, and he lost faith in the Jedi Order. This left him prone to the pull of the dark side. Strength and eventually fell to the dark side. [15] At the end of the war, the Supreme Chancellor - secretly Darth Sidious, Dark Lord of the Sith - transformed the Republic into the Galactic Empire and declared himself emperor of the galaxy. During this time, Sidious recruited him to become the great inquisitor of the Inquisition. [15] The age of the Empire serving Lord Vader the Inquisitor entered the service of the Reich and the Sith, even though he was not a Sith himself. When the Inquisitor entered the archives of the Jedi Temple, he was confronted by Sith Lord Darth Vader, who was once Anakin Skywalker before his own fall to the dark side. He and Vader argued until Vader damaged his lightsaber. The fight was then stopped by the Emperor, who explained to Lord Vader who the Inquisitor and inquisitor were. They then went to the inquisition headquarters in the Works to meet the other Inquisitor. [9] Vader then commissioned the Inquisitor to hunt down and eliminate all Jedi who survived Order 66.[1] an order given to clone soldiers of the Great Army of the Republic to destroy the Jedi Order. [17] To achieve this task, the Inquisitor was trained in the ways of the dark side[1] and studied the records of the Jedi Temple to better know his enemies. Luminara Unduli's hologram, taken as she looked up to the Inquisitor in the moments before her death One such Jedi that the Inquisitor led to their deaths, was Jedi Master Luminara Unduli. After the execution of Order 66, Unduli was captured and held in Spire.[18] a former separatist[19] imperial prison on Stygeon Prime. [18] At the end of it, Unduli was in the presence of the Inquisitor, who was standing in the doorway of her cell when she entered the execution chamber and died. The Inquisitor kept her remains in a prison cell and used them to steer other Jedi to their deaths when they heard rumors that Unduli was still alive. [15] As part of this ruse, the Empire retained a holographic recording of Unduli and her executions. [18] When he became the Rank of Grand Inquisitor, he led other members of the Inquisition. Among these inquisitors were dark warriors such as the Second Sister, the Fifth Brother,[20] the Sixth Brother,[21] the Seventh Sister,[20] the Eighth Brother[22] and the Ninth Sister. Like the Great Inquisitor, these Inquisitors had their roots in the Jedi Order. [12] As a great inquisitor, the dark adept hunted and fought the former Jedi padawan naq honey. His lightsaber was damaged in a duel, and Med escaped.[23] At another point, the Grand Inquisitor took power-sensitive children from an orphanage on Gaaten. One night, when he went to the orphanage, he was confronted by a surviving Jedi, Kira Vantala, to whom the Great Inquisitor expressed his shock and believed he was a weak Jedi. The Inquisitor was defeated by Vantala and a fugitive named Elish and never returned to the orphanage. [24] Evidence of another survivor Set course back to And inform Lord Vader that we have found evidence of another survivor. A year after the rise of the Galactic Empire, the Grand Inquisitor was alerted to the presence of a force sensitive to being old enough to be trained by the Jedi on the agricultural moon of Raada. Even though he wanted to hunt down the alleged Jedi himself, he needed it elsewhere, and instead assigned the task to the Sixth Brother, who then went to Raada to set a trap for sensitive forces. In the following battle, however, he was killed, and the Jedi, as well as the farmers who rebelled against the recent occupation, fled. Meanwhile, the Grand Inquisitor was alerted to the situation and traveled to the moon with a fleet of Star destroyers to provide reinforcements, but by the time they arrived, the insurgents were gone. The Grand Inquisitor personally examined the damage caused by the battle and discovered the corpse of the Sixth Brother. Although he was upset by the incompetence and recklessness of his subordinate, the Great Inquisitor was impressed by what the Jedi had done. Then he returned to his ship and ordered his agents to set a course back to base and inform Darth Vader that they had found evidence of another survivor - in fact, it was Ahsoka Tano, Anakin Skywalker's former padawan. [21] Jedi on Kashyyyk At 14 BBY, the Great Inquisitor heard about the Jedi who caused problems for the Kashyyyk Empire. This Jedi was Cal Kestis, who helped some guerrillas attack the Imperial Refinery. The ninth sister told the great inquisition that Kestis would not have the courage to return to Kashyyyk, especially after the resistance had been eliminated by the Sororm. The ninth sister was later proved bad and defeated by Kestis when he returned to Kashyyyk. [26] The Children of the Force The Emperor foresaw that a new threat would arise against him: the children of the Force. It must not become Jedi. Yes, Lord Vader. Hunt down this new enemy, and if they don't serve the Empire, eliminate them along with the surviving Jedi who would train them. This is my master's order. Darth Vader and the Great Inquisitor[src] In the years before the Battle of Yavin, the Great Inquisitor was contacted by Darth Vader, who told the Jedi hunter that the Emperor foresaw a new threat that would arise to challenge his rule: the children of a force that could not be allowed to become Jedi. Vader ordered the Inquisition to hunt these individuals down and either to serve the Empire or destroy them, along with jedi survivors who could train them. With orders from the Emperor, the Inquisitor told Vader that it had happened. [27] The Grand Inquisitor was ordered by Darth Vader to hunt the children of the Force. One of the methods used by the Inquisitor to find people sensitive to force was to look cadets from the Academy of Young Imperials at Lothal who met a set of criteria that indicated their ability to use the Force.[28] an operation known as Project Harvester. One of the well-known targets of the Harvester project was Dhara Leonis, a promising cadet and daughter of imperial agricultural scientists. The imperial authorities tried to cover up her abduction by claiming she had escaped from the Academy. But her mother Tephra and younger brother Zare Leonis suspected the Empire was lying. To find out his sister's fate, Zare enrolled at the Academy the following year. [30] A little later, fourteen years after the rise of the Reich, a group of rebels operating on Lothal came to the attention of Agent Kallus of the Imperial Security Office. The insurgents rescued a group of Wookiees who had been enslaved at a spice mine in Kessel, a mission in which rebel leader Kanan Jarrus used a lightsaber to reveal himself as a Jedi survivor. After the rebels fled, Kallus contacted the Inquisitor and informed him of what had happened on Kessel. The Inquisitor was pleased that Kallus informed him of the rebel cell and the Jedi in its ranks. [27] Stygeon Prime Trap Yes, I'm afraid Master Luminara died with the Republic, but her bones continue to serve the Empire. He lured the last Jedi to the end. The Great Inquisitor Kanan Jarrus and Ezra Bridger[src] The Grand Inquisitor set a trap for Jarrus and his padawan Ezra Bridger in the Tower. The Empire was able to project an image suggesting that he was alive, and this information was then reported by Gall Trayvis, a former member of the Imperial Senate, who claimed to have gone into exile after speaking out against the Empire[18] - in fact, Trayvis was a loyal agent of the Empire who used his position to trap rebel groups into the traps of the galaxy around the galaxy. [31] The rebels did not want to miss the opportunity to save the surviving Jedi and made a mission to the Tower, where they intended to save the Jedi Master. The Grand Inquisitor is fighting Kanan Jarrus. Once in prison, the rebels fought their way through the stormtroopers stationed there. Jarrus and Bridger got into the detention center, and Jarrus believed he could sense the Jedi master — when in fact, it was the power of her bones. They entered the cell and saw a projected image of Unduli disappearing into a sarcophagus that revealed the remains of a Jedi master. The Great Inquisitor entered the cell, his lightsaber ignited, approached the two Jedi, and revealed that Luminara had been dead for many years. Jarrus attacked the Inquisitor, and they both engaged in a lightsaber fight. The Inquisitor was able to correctly deduce that Jarrus was trained by Jedi Master Depot Billaba because she was a teacher of Form III lightsaber combat in close combat, which Jarrus employed extensively. The two continued to fight inside the cell until Bridger removed the small detonator that allowed and Jarrus escape. Although they escaped from the cell, the Great Inquisitor pursued them and continued to fight Jarrus in the corridors of the prison. He soon pushed Jarrus away by force and, at Vader's command, tried to bring Bridger to the dark side. But the boy refused, and the Inquisitor was about to throw him down, but Jarrus used the Force to pin the Inquisitor to the ceiling, giving both Jedi a chance to escape. The Grand Inquisitor followed them and chased them through prison before reuniting with their rebels. The Inquisitor, separated by several closed doors, cut through them a lightsaber and arrived in time to see the rebels begin to escape. The last time he tried to stop them was by throwing a lightsaber at them, but Jarrus repelled him, and the rebels escaped aboard the Phantom, the attack shuttle that belonged to their main ship, the Spirit. [18] Incident at the Imperial Academy Well, Leonis, let's go for a walk, shall we? I want to know all about your old friends. The Great Inquisitor, behind Zare Leonis the Grand Inquisitor speaks to Zare Leonis. After failing to stop the rebels on Stygeon Prime, the Inquisitor was contacted by Commander Cumberlayn Areske, a senior officer at the Imperial Academy at Lothal, who informed him of two students who potentially met his criteria for sensitivity to force. He learned that these cadets were Dev Morgan - who was unknown to the Academy, Bridger in disguise, who infiltrated the Academy to find out the location of a huge cyber crystal of great power - and Jai Kell. After the Inquisitor learned this information, he told Aresk through a hologram that he would arrive at the Imperial Academy the next day. Bridger overheard the conversation, and he and Kell fled the Academy with another cadet, Zare Leonis, who suspected that the Inquisitor was behind the disappearance of his sister, Dhara Leonis; Dhara was a star cadet at the Academy before her disappearance, which the Empire claimed was the result of her escape from the Academy. Upon arrival at the Imperial Academy, Aresko and Agent Kallus informed him of Bridger and Kell's escape. Jedi hunters were shown the datasets of both cadets and recognized Dev Morgan as Bridger from their meeting on Stygeon Prime. The Inquisitor informed Aresko that the incident was a black spot in the Academy's records, although he had a chance to learn more about the rebels, as Leonis was also present at the meeting. During the escape, Leonis decided to stay to find out what happened to his sister, pretending to try to stop Bridger and Kell from escaping. The Inquisitor spoke to Leonis and told the cadet to tell him everything he knew about Bridger and Kell. During a private conversation with Leonis, the Inquisitor led the young cadet into the interrogation room. Once inside, the Inquisitor asked Leonis everything he knew about Morgan while he tried to explore the cadet's thoughts. While Leonis hid his collaboration with Morgan, he pretended to support the Inquisitor's assessment that there was something wrong with Morgan. When the Inquisitor told Leonis that Morgan was a pseudonym, Zare pretended to be the perfect cadet and asked if the victories in his assessment would be released. The Inquisitor merely replied that he should ask the Commander of Aresko. [29] Zare then tried to convince the Inquisitor that he was as sensitive to force as his missing sister Dhara. He said he somehow sensed something was wrong with Dev and Jai and that they were hiding something. The Inquisitor quickly deduced that Leonis was Dhar's younger brother. While the Inquisitor was fully aware that Dhara had been kidnapped and forcibly introduced to project Harvester, he repeated the official imperial description that Dhara had been only escaped. When Zare claimed that he and his sister would always sense each other's presence, the Inquisitor only told the young cadet that it made sense and that in time he would understand why. [29] Scuffle at Vyndade Another Jedi! That's a real surprise. How many more padawans did you take? He's not my padawan. Then you won't be emotionally compromised when he dies. The Great Inquisitor, Kanan Jarrus, about Protector Jeleb, the Inquisitor and his imperial forces, arrived in a village on the planet Vy took out to search for Jarrus after being seen nearby. The Inquisitor and his troops were greeted by the protector of yeleb village, who lied to the Inquisitor that he had not seen Jarrus in their village; But the Inquisitor could see through the protector's lies, and when Yeleb ordered the Emperors to leave, Pau'an ordered his stormtroopers to destroy the village. [32] The Grand Inquisitor will take on Yeleb alongside the Jedi Jarrus. That's when Jarrus exposed himself to the Inquisition and attacked him. Yeleb also soon joined the fight, wielding his own lightsaber with green blades, leading the Inquisitor to assume that Yeleb was also a Jedi, although in fact, a few years earlier Yeleb had taken a lightsaber from a crashed Eta-2 Actis-class light destroyer with a dead Jedi pilot inside. The Inquisitor used the Force to push Jarrus out of the fight, allowing him to focus on Yeleb and cut the man across the chest with his blade. After Yeleb collapsed to the floor, the Inquisitor took Yeleb's lightsaber, and Jarrus fled the Inquisitor to distract him from the wounded man. Pau'an and his stormtroopers pursued him, and Jarrus managed to trick the Imperials into thinking he had escaped from Vyndal on one of their cruisers, causing them to chase him and leave the planet in the other. [32] After the Imperials left the planet, Yeleb died of his injuries, and Jarrus eventually left the planet and returned to the rebels, leaving the people of Vydal hop that without him and the light meza on the planet, the Empire they didn't come back, and even if they did, people could protect themselves. [32] Empire Day I still feel the Jedi and his padawan at my fingertips. When the rebels tried to smuggle Tseeb, an Imperial Information Office worker who had fled with imperial secrets at Lothal, he led a TIE fighter squad while piloting his own TIE Advanced v1 to prevent them from escaping. He was able to deploy an XX-23 S-thread tracker to their ship moments before they jumped into hyperspace. [33] The Grand Inquisitor at Fort Anaxes realized they were being watched, Jarrus and Bridger boarded phantom and ejected from Ghost and flew it to Fort Anaxes. The Inquisitor took with him a unit of soldiers and its commander aboard a Sentinel-class landing craft to confront both Jedi. When the Inquisitor and his soldiers entered the base, they spotted Jarrus and Bridger along with a number of phynocks. Two Jedi used the Force to throw the Fynocks to attack stormtroopers. Jarrus fought the Inquisitor again, but was easily defeated and stunned. The Inquisitor cornered Bridger and told him to give in to the dark side and that his friends would die and that everything he fought for would be lost. Bridger briefly succumbed to the dark side and summoned the giant fymock to attack the Inquisitor. Jarrus awoke, grabbed Bridger, and recovered his lightsaber. After banching mother fymnock, the Inquisitor tried to stop their escape, but they managed to board their ship Phantom and destroy the imperial landing craft. The Inquisitor accepted his failure and simply stated that his Master would not be pleased. [10] Dealing with Zare Leonis Who can doubt the commitment of such a promising young cadet? The Great Inquisitor probing Zare Leonis[src] After the Lothian rebels attacked the Celebrations of Empire Day, the Great Inquisitor returned to Lothal to deal with another unfinished business: Dhara Leonis' younger brother Zare Leonis. While Zare was a promising cadet at the Academy of Young Imperials who earned the glowing praise of his instructors, the Inquisitor suspected Leonis was associated with Ezra Bridger and other Lothian rebels. A great opportunity for his action against Zare came when a young cadet took action against a ruthless cadet named Nazhros Oleg who tried to protect his smuggling uncles from imperial justice. Under the pretext of rewarding Leonis, the Inquisitor arranged for the cadet to be transferred to the Arkanis Academy, which was associated with the Harvester project. There he hoped to create circumstances that would expose Leonis as a traitor to the Empire. In addition, the Inquisitor wanted to find out if Zare was really sensitive to power, as he had previously claimed. [34] After Leonis' raid on a group of smugglers, the Inquisitor and Piers Roddance called Zar for a private meeting. When Leonis implied that Oleg didn't really know his uncles were involved in smuggling, and suggested showing the delinquent a little compassion, the Inquisitor replied that compassion was the most infeasible thing. After ordering Captain Roddance to leave the room, the Inquisitor told Leonis that he had arranged for the cadet to be transferred to Arkanis Academy as a reward for his loyalty to the Empire. Throughout the meeting, the Inquisitor tried to explore Leonis' thoughts. [34] The Grand Inquisitor suspected that Leonis had ties to the rebels, thanks to his association with Ezra Bridger. Leonis pretended to be a model cadet and expressed gratitude for the opportunity to serve the Empire. The Inquisitor senses Leonis' real motivations for joining the Imperial Academy and instructs Leonis by asking who might doubt the devotion of such a promising young cadet. Intimidated by the Inquisitor, Zare turned away from pau'an's gaze and called on the Inquisitor to ask the cadet to make eye contact with him. Before Leonis' departure, the Inquisitor told the cadet that he was looking forward to his training on Arkanis and assured the cadet that his service to the Empire would be more important than he had hoped. While Leonis wasn't sure if the Inquisitor knew his real program, his girlfriend Merei Spanjal revealed imperial documents confirming that the Inquisitor intended to use Arkanis' move to break up the young cadet. [34] Later, the Inquisitor visited the Arkanis Academy and landed in Area Null, a remote tower of the academy that hosted several top-secret imperial projects, including the Harvester project and the Unity Project, which was a program to educate former dissident youth. After dinner with Commander Brendl Hux and the cadets in the academy banquet hall, the Inquisitor summoned Cadet Leonis for a private meeting on the commander's balcony. There, the Inquisitor asked Leonis why he had tried to enter null, even though it was forbidden for cadets. Leonis said he thought the cadet was in trouble, but the Inquisitor quickly realized he was lying. [35] He then gave Leonis a second chance to answer his question. Leonis said he sensed in the tower that

dignitaries that from now on there would be consequences of failure. Based on these words, the Inquisitor activated the lightsaber directly behind Aresk and Grint and lowered the rotating element, chopping off the heads of both officers while a horrified Tua and Kallus watched. When Kallus found out that the rebels were planning to attack the Imperial Communications Tower, Tarkin ordered him to let them enter the tower, but prepared his troops to intervene as soon as they did. After Kallus left, Tarkin told the Inquisition that it was his chance to redeem himself for his previous failures. Pau'an promised Big Moff that his faith would be rewarded. The Grand Inquisitor is fighting Jarrus in front of the communications tower. After the rebels attacked the tower, Kallus and his troops intervened, surrounding the tower and forcing the rebels to flee to the roof. Only Kanan Jarrus remained to give them time to escape, at which point the Inquisitor arrived to confront the Jedi. Jarrus destroyed the console and gave them access to the tower. The Inquisitor and the Jedi fought again, and the first to realize that Jarrus had improved his technique. But the Inquisitor has once again proved to be the strongest of both, and he will overpower Jarrus with force. However, the rest of the Rebels escaped. While Jarrus was in custody, the great Moff Tarkin arrived and received a captured Jedi in a sign sent by the rebels, who began broadcasting the tower. Tarkin ordered the tower destroyed before he left with his prisoner. [39] Kanan's interrogation Tell me, Jedi, how did you survive Order 66? It was your Lord Billaba who gave his life for yours. Do you remember her last words? Her last and last breath before she died? Yes, right? You see it in your sleep, you hear her voice when you wake up. Tell me Jedi, what was her last word? Run. The Great Inquisitor asks Jarrus about the last words of his master[src] The Great Inquisitor uses the Force to try to force Jarrus to reveal what he knows about the rebels. After Kanan was captured, he was brought aboard the flagship Grand Moff Tarkin in orbit over Lothal: sovereign. Tarkin and Kallus continue to interrogate Kanan with a mind probe, but the Jedi have proven stronger than this tactic. As Tarkin was more frustrated by the lack of results, the Inquisitor arrived and told them that the Jedi had been trained to withstand the probes of the mind. Instead, he argued that pain would be a more effective technique, as the Jedi still felt. The Inquisitor used the Force to try to pry information from Kanan's mind, but the Jedi resisted again. Instead, the Inquisitor electrocuted Kanan to let him talk. But it turned out that the rebel was much stronger than he thought, and resisted torture. The Inquisitor believed that Kanan knew nothing of a greater rebellion. Tarkin proposed to relocate it to a facility that never failed and got results. The monarch then left Lothal for Mustafar, a world deep in the Outer Rim. [40] The Grand Inquisitor continued his interrogation with Governor Tarkin Nad Mustafar, and the Inquisitor continued to question Kanan, asking him about other rebels he might have known. Specifically, he wanted to know about a mysterious rebel known as Fulcrum. Still refusing to speak, Kanan changed tactics: he asked Kanan how he survived Order 66. When Kanan did not answer, the Inquisitor revealed that he knew how; Jarrus' master Depa Billaba sacrificed herself to save him, and in the doing so, she lost her life. The Inquisitor sneered at Kanan and asked him if he remembered the last words of his Lord, and Kanan replied that she had told him to run away. The Inquisitor told Jarrus that he could save his friends no more than he could save his Lord, because he feared his own power, nor did he dare to carry his lightsaber in public because of it. When the alarm went off, the Inquisitor unconvincedly discovered that the other rebels had come to rescue their friend. [4] The confrontation aboard the monarch You have no idea what you have unleashed here today. Things are so much scarier than death. The Grand Inquisitor, who spoke to Kanan Jarrus just before he was released and fell into an exploding reactor after Ezra tore Kanan out of his cell, headed back to their evacuation ship through the generator complex. The Inquisitor was waiting for them and lit his lightsaber. Kanan borrowed Ezra's lightsaber and attacked the Inquisitor. When he tried to get to him, he activated the lightsaber stun gun and surprised his opponent. The two engaged in a lightsaber duel with Kanan using both a blade and a stun gun to attack the Inquisitor. When Ezra used the Force to pluck Kanan's lightsaber from the imperial agent's belt, the Inquisitor disconnected from the battle with Kanan and activated his second blade, claiming that he would finally get the challenge he always wanted. After a brief engagement, he used the Force to push Kanan back before throwing his rotating lightsaber at Ezra, who had fallen out of the way, to Kanan's horror. [4] The Grand Inquisitor releases the platform and falls into the monarch's exploding reactor. Kanan, disturbed by the apparent loss of his padawan, remained on his knees for a moment as the Inquisitor stood over him, sadistically smiling at the apparent anxiety of the Jedi. Eventually, however, he pulled himself together, remembered his Jedi training, and stood up. When the Inquisitor asked him what would happen now that no one else was going to die for him, Kanan replied that he had nothing left to worry about. Then he used the Force to draw a lightsaber for him, both with him and with Ezra. After greeting each other, the Inquisitor and the Jedi continued their battle. This time, however, Kanan proved to be a much more effective enemy, gradually he began to drive the Inquisitor back, the second of which began to show fear and uncertainty for the first time. As the Inquisitor came dangerously close to the edge, Kanan interrupted the fight to say that his enemy was right: he was a coward, but that he had discovered that there was something far more powerful than fear: the Force. The Inquisitor had his blades filmed to defend himself, but Kanan destroyed the Inquisitor's lightsaber, and the imperial agent fell off the edge and caught the side of the road as he fell. Both halves of his light mule hit the generator, causing it to catch fire and trigger a chain reaction inside the Sovereign. [4] As Kanan stood over his defeated enemy, the Inquisitor looked up to him and told him that his defeat would leave something much worse on everyone. The Inquisitor knew what punishment he would receive for his failure, and told the Jedi that some things were far scarier than death before he let himself fall into an exploding generator and kill himself. [4] The posthumous envoy of Master Yoda Temple falls. Go. I'll delay the enemy. -Sentinel, Kanan Jarrus[src] Inquisitor's warning to Jarrus turned out to be true. With their chief agent on Lothal's death and a growing rebellion in the galaxy, the Empire sent a much more deadly agent to Lothal to up root out and destroy the rebels: Darth Vader. [4] After Vader attacked and paralyzed the Phoenix Cell and discovered that his former Padawan, Ahsoka Tano, was still alive and in line with the rebellion, the Emperor ordered Vader to send another Inquisitor to hunt the rebels. Vader sent the Seventh Sister and the Fifth Brother, both hoping to become the new grand inquisitor. [20] The Great Inquisitor's vision as sentinel fights Jarrus at the Jedi Temple on Lothal. Sometime after the death of the Great Inquisitor, Jarrus and Bridger traveled with Ahsoka Tano to the Jedi Temple on Lothal to seek the guidance of Jedi Master Yoda, with whom Jarrus and Bridger had previously communicated. It was there that they hoped to find a clue on how to deal with the threat of the Inquisitor, who attacked the rebels at any moment. When Jarrus was in the temple, he entered a vision in which he saw the Jedi Temple Guard known as the Sentinel inside the dojo. [7] Jarrus was not known, it was a vision enchanted by Yoda the Great Inquisitor, as the Jedi once did. The Sentinel warned Jarrus that Bridger would fall on the dark side of the Force and that the boy must be eliminated. Jarrus refused, and they both engaged in a lightsaber fight. At the end of the duel, Jarrus refused to fight on, admitting that even if he could not protect Bridger forever, he would continue to try to train him. Sentinel looked like Jaruse wanted to strike, but instead performed a chivalry ritual. Then he took off his mask to reveal the face of the great Inquisitor. Jarrus asked what it all had and the Sentinel said it meant Jarrus was now a Jedi knight, like the great inquisitor once was. When the Seventh Sister and fifth brother descended on the temple, the Sentinel told Jarrus to run away and said he would hold off the enemy. The Sentinel's vision, flanked by other Jedi temple guards, surrounded the two Inquisitors as Jarrus, Bridger, and Tano fled the Jedi Temple. [7] At 0 BBY, shortly after Jarrus' own death, his confrontation with the Grand Inquisitor could be heard among bridger's numerous voices as he walked through the hyper tunnel as he rode loth-wolf on his mission to the Lothal Jedi Temple. [43] The Eternal Pawn of the Sith I served... for so long. He'll never be there... be a chance... Release? You're just an instrument shaped to serve my purposes. You... Continue. -The Inquisitor's spirit and Darth Vader[src] The spirit of the great inquisitor haunted Tempes. Despite the defeat to Mustafar, Pau'an's usefulness to the Sith has not withered. Darth Vader's intervention prevented the great Inquisition from leaving the mortal world; instead, Vader forced the Inquisitor to serve his purposes. The Dark Lord has put his servant on a Jedi base from the time of the High Republic on Tempes in the hope that anyone who seeks knowledge from this place will be trapped in his trap. The spirit of the Inquisitor, who is still burning[5] from the flames that destroyed his body aboard the Sovereign,[4] has pursued the building for years, killing all the seekers of knowledge who have entered its halls. At some point, the partially trained Padawan Verla discovered the base, but left the site after sensed the dark presence of the Inquisitor who was staying inside. [5] After losing his lightsaber in a duel with Vader in Cloud City[5] at 3 ABY,[3] aspiring Jedi Luke Skywalker learned of Tempes base from Verba and traveled there in the hope of getting a new weapon. Inside, the Inquisitor's spirit confronted the boy and benequised him for his lack of training. Skywalker, armed with the lightsaber of the Jedi Temple Guard, fought the spirit. The ghostly Inquisitor gained the upper hand in the duel, knocking the Jedi advisor to the ground and mocking him for his devotion to the Jedi Order. While the far side demented that the Force had not saved the Order from extinction, the sight of ancient relics on the base, which still stands for centuries, motivated Skywalker to push back. The aspiring Jedi realized that service to the greater good was worth dying for, and with his new weapon he cut off the clergyman's hand and brought him a cut on his chest, causing the Inquisitor to disappear. [5] In another part of the galaxy, Vader sensed a scuffle on Tempes and ordered the crew of his shuttle to take him there. By the time he arrived, however, Skywalker had already escaped. He helped the Inquisitor, whose ghostly figure had been corrected. Pau'an begged Vader and begged to be freed from the curse of the Sith Lord. granted to him. Vader, however, was not satisfied with the work of his servant and refused. The Inquisitor watched Vader leave a place he couldn't, and repeated to himself that things were worse than death before disappearing into the darkness. [5] Personally and traits Compassion is the funniest weakness of all... Inquisitor, in response to a comment by Zare Leonis[src] Man Pau'an, the Great Inquisitor vomited ahen[6] white skin,[8] stood 1.98 meters in height and weighed 80 kilograms. [6] Before falling to the dark side, his eyes were gray and silver irises and eyes, along with light red marks around his eyes and on the sides of his face. [7] After his fall, the sclero and zofo of the great inquisitor turned black, and his irises turned yellow with red rims. He also adorned his face with a tattoo of the dark side[1] tattooed in the same shade of red as human blood,[8] shousng fear into the targets and subordinates. [44] Although he was a physical adversary to the Jedi and connected to the dark side of the Force, he did not seem too emotional, instead functioning as a cold and analytical mind. Whatever intensity he showed was the result of his intention to complete his mission. [45] Across the dark side, the Great Inquisitor could learn about individual Jedi and use his secrets against them. [1] He studied the records of the Jedi Temple[18] to not only identify the Jedi, but also to understand their fighting forms and traditions. His knowledge was so extensive that he could identify who the Jedi was trained,[1] for example, when he identified Depot Billab as Jarrus' Jedi Master,[18] and identified their fighting style in 10.6 seconds. [46] He used it, like his lightsaber, to cause fear to his opponent, which was his strongest weapon against his enemies. Once in battle, he had no mercy because he was charged with assessing and removing Jedi survivors. [1] The Inquisitor also supported Captain Piers Roddance's view that the Empire must be cleansed of all weakness and considers compassion to be the most terrible weakness. [34] After realizing that he had been defeated by Jarrus, the Great Inquisitor chose death rather than face the wrath of his Master for his failure. [47] However, Vader could not truly escape, because the Lord of Evil continued to use the spirit of Pau'an for his personal needs. After years of serving as Vader's watchman on Tempes, the Inquisitor believed he would be cursed to do so for eternity. [5] Powers and abilities I know my training is not complete. But I'm not exactly a beginner. I don't, too. Luke Skywalker and the spirit of the Inquisitor prepare for battle during their duel. The Grand Inquisitor was a practitioner of the dark side of the Force and trained in lightsaber combat.[1] he learned to use and face all seven forms recognized by the Jedi Order. [48] He wielded a two-petalled lightsaber,[1] which he used in several one-leaf, two-leafed, as well as two-leafed with blades rotating on the handle. [18] In addition to using the weapon to make his enemies nervous, he controlled it to quickly and effectively end the fight with as little effort as possible. This allowed him to execute the Jedi he had encountered. The Inquisitor also demonstrated skills in using two blades to the point where he used a single-blade lightsaber and his two-blade rotating lightsaber at the same time, such as when he fended off a giant fyrnock in Fort Anaxes. [10] The Grand Inquisitor had certain skills in Makashi, managed to maintain his superiority over Kanan Jarrus twice while using form before quickly defeating him. [46] He sometimes used a one-handed combat technique not unlike that of Master Count Dooku. [48] Master Makashi. In addition to being an impressive duelist of lightsabers, the Grand Inquisitor was skilled at using telekinesis. He had enough telekinetic power to push Kanan Jarrus across the hall and throw a lightsaber with deadly precision. [18] The Inquisitor had a bright Force Sense, demonstrating during the pursuit of Kanan Jarrus and Ezra Bridger on Empire Day. [10] When questioned by Kanan, the Inquisitor showed affection for mind tricks and the mind probe, allowing him to potentially force his victims to reveal information or scan their thoughts and emotions for them. [40] He was also an experienced pilot and routinely demonstrated his ability to fly a TIE prototype while hunting rebels. [1] Even after his death, the Great Inquisitor was a force to be reckoned with. He served as a formidable adversary of young Luke Skywalker, even though the boy was able to remake him in battle. As a spirit, the Inquisitor was able to hover above the earth and physically communicate with his surroundings,[5] much like the spirits of the Force on the light side. [50] In this condition, he could also be injured, grinning noticeably in pain and disappearing into the air after Skywalker cut off his ghostly hand and cut his chest. But these wounds were not permanent, because the Inquisitor was later able to reform himself. [5] During the days of the Jedi Order, the Jedi Knight of The Jedi, who was to become a great inquisitor, wore a formal robe and mask concealing identity.[11] the ultimate expression of the emotional separation required in the service of a higher calling. [51] He also carried a folding pike of a lightsaber,[7] a thick and imposing two-bladed weapon that produced a distinctive yellow blade. [51] As an Inquisitor, he wore an imperial-style uniform and, on one occasion, a hooded robe over his imperial uniform. [9] During his flights in his star-studded TIE Advanced v1 match, he wore a special Adjutant helmet. Like Pau'an, he wore blankets to protect his hypersensitive ears. [46] The Grand Inquisitor carried his own gyroscopic two-leaf lightsaber,[1] a shared weapon among members of the Inquisition. [53] He used this to intimidate his opponents. In particular, he was able to balance an inexperienced Jedi. Because the Jedi relied on balanced emotions, the imbalance gave the Inquisite an advantage in battle. [1] He carried this weapon as a ghost. [5] Backstage Once we put our heads on Utapauan, it all kind of clicked into place. Suddenly, the evil inquisitor in the black suit appeared. When designing a character dubbed by actor Jason Isaacs,[45] the look and kind went through several iterations and was the subject of a great discussion in Lucasfilm. [1] The production team wanted to ensure that the character was not a copy of past iconic villains such as Darth Maul or Darth Vader. [45] At one point, the Inquisitor was designed as Chagrian. [54] Eventually, they decided to turn the character into Pau'an, which, according to the show's executive producer Dave Filoni, was when the character took its place. Fellow executive producer Simon Kinberg felt it added real and human quality to the character while evoking a creaturely, frightening and frightening look. [45] Conceptual art for the Grand Inquisitor in further distinguishing the Inquisitor from past villains, the production team created him as a cool and analytical figure who presents himself as elegant, sophisticated and educated. [1] Moreover, they did not believe that he was similar to the villains from the 1980s cartoons that Lucasfilm's Pablo Hidalgo described as the villains losing in each episode, yet they were presented as a credible threat. Instead, the Inquisitor is supposed to be someone whose arrival is significant and a challenge for the rebels. [45] The character was unveiled at New York Comic Con 2013 during a panel on the show, which screened a video featuring the Inquisitor as a Jedi hunter who would be a recurring adversary of heroes. The Inquisitor first appeared on screen in Star Wars Rebels: Spark of Rebellion, which premiered on October 3, 2014. [56] On October 28, 2015, Filoni revealed that the Great Inquisitor had appeared in Star Wars: The Clone Wars, even though the audience didn't know it. [57] An episode of The Shroud of Darkness revealed that the Inquisitor was once a Jedi temple guard and Jedi knight. [7] At a press conference for Twilight of the Apprentice, the finale of the second season of the series, Filoni revealed that the Grand Inquisitor was in the finale of season five of The Clone Wars, The Wrong Jedi, as one of the Jedi temple guards who accompanied Ahsoka Tano from the Jedi Temple and brought Barriss Offee before the Supreme Chancellor. [14] At Dragon Con 2018, Henry Gilroy revealed the idea that the Inquisitor murdered other temple guards when Order 66 accidentally allowed Anakin Skywalker and the 501st Legion access to the Jedi Temple.
